You can classify expenditures based on the type of cost incurred on a project, such as administrative, overtime, or lodging. You can then group the project costs into specific expenditure categories – such as Materials and Labor – for increased visibility and control of project costs. With Oracle Project Costing, you have multiple ways to enter project expenditures. You can enter transactions directly or load from external transaction collection systems.

Oracle Project Costing lets you track total project costs by applying a buildup of burden costs to the raw costs, eliminating the need for end-of-month allocations of indirect costs. Oracle Project Costing maintains date-effective schedules of burden multipliers, so retroactive changes are processed automatically and a complete audit trail is maintained. For each overhead component, you can assign various rates for each cost type – you can have one set of overhead rates for labor and another for materials. You can also vary rates by business unit, geography, or by the type of project – including internal projects or contractual work.

When the allocation of indirect cost is preferred over the application of overhead rates, robust allocation tool in Oracle Project Costing streamlines the process. You can aggregate your indirect costs into a general ledger account or separate indirect project, and then allocate the cost periodically across your direct projects and tasks. You can define allocation rules for each business unit. The flexible allocation workbench enables you to create and review draft allocations online – before you release the final cost amounts to your financial systems.

Manage the Global Enterprise

With Oracle Project Costing, you can establish global project offices and shared service centers while remaining flexible enough to support the myriad of regulations and statutory requirements in the global marketplace.

Handle Transaction in Any Currency

Oracle Project Costing supports the need of your global workforce to incur transactions, receive reimbursements, generate accounting entries, and review project costs – all in different currencies. Besides using any currency defined in your financial systems, you can configure different operating units or projects to use specific currencies. When costs are allocated to projects, they are automatically converted to the appropriate currency. The entire project team can better understand their project costs by having a standard currency for comparison and analysis.

Streamline Resource Sharing Administration

Expand your employee resources by building virtual teams across organizational boundaries. Using the cross charge feature in Oracle Project Costing, your employees can work on projects owned by operating units, organizations, and legal entities other than their own. Oracle Project Costing provides additional cost controls for resource sharing across business units.

The powerful cross charge functionality in Oracle Project Costing provides a solution for centralized project management, while allowing you to maintain your employees in their respective organizations. This structure eliminates the need for duplicate administrative efforts, because you define your HR records and cost rates only once. While this feature provides flexible and powerful back-end processing,

Oracle Project Costing provides you with the flexibility to determine how to account for resource sharing activities, including transfer prices, multiple calendars, and local currencies. This flexibility can help your enterprise address the disparate accounting, legal, and tax requirements you encounter in a global work environment. You can create borrowed and lent accounting entries to reflect cross charge transactions, or create internal invoices for a more formalized paper trail.

Manage Your Project Costs

Oracle Project Costing enables you to easily monitor and control your project spending. You can use transaction controls to limit the expenditures that users can charge to specific projects using criteria such as expenditure category, employee, or date range. These controls help prevent users from charging incorrect or excessive costs to a project so that your projects can be as profitable as possible. For example, you can create a transaction control to limit the types of transactions that contingent workers can charge while still allowing your regular employees to incur those costs.

Budgetary controls help further manage your project costs by only processing transactions if there are sufficient funds available in the project budget. You can set up different control levels, which place hard or soft limits on what can be charged to the project. For contingent workers, funds can also be controlled by the purchase order agreement, ensuring that entered amounts never exceed the agreement amounts. Budgetary control balances are automatically updated as transactions are entered providing a real-time view of cost to date, outstanding commitments, and available funds.

Easily adjust your project costs online, interface the adjustments to your financial systems, and provide a historical audit trail of all activities. You can perform a wide variety of adjustments – including correcting approved expenditures, changing the billable status of expenditure items, recalculating raw or burdened costs, splitting expenditure items, and transferring expenditures to another project.

To help you manage project costs, Oracle Project Costing provides detailed analysis of how your actual costs compare to your project budget. Compare both actuals and outstanding commitments to your original and current budgets, and drill down from the summary of project costs to see the cost details at the task or transaction level. By having aggregated and detailed project cost information in a single repository, you can easily analyze cost trends and quickly identify any problem areas for all levels of your project.

Oracle Project Costing can also allocate common costs across assets and summarize asset cost for reporting and capitalization. When you are ready to place assets in service, you can automatically generate asset lines from the CIP costs and send the lines to your asset management system, such as Oracle Assets, to become depreciable and fixed assets.

Oracle Project Costing also captures the cost of asset removal and the proceeds of sales for any assets you are retiring – for example, a utility company that replaces existing light poles and sells them as firewood. When your retirement activities are complete, you can automatically generate asset lines and send the lines to your asset management system for posting as adjustments to asset depreciation. The tight integration between Oracle Project Costing and Oracle Assets allows you to eliminate redundant data entry and to seamlessly make adjustments to your assets – even after capitalization.
